## SPORT CLIPS® HOLIDAY HALFTIME SWEEPSTAKES OFFICIAL RULES

## NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE CHANCES OF WINNING.

- 1. ELIGIBILITY: The Sport Clips® Holiday Halftime Sweepstakes (the "Promotion") is open only to individuals who are living within (and are legal residents of) the 50 United States and DC who are at least 18 years of age as of the date of participation. Employees, officers and directors of Sport Clips, Inc. ("Sponsor"), Promotion Mechanics, Inc. For the purposes of awarding the Daily Prizes as described below in Section 4, the Entry Period is further divided into "Days", where each Day begins at 12:00:00 AM CT and ends at 11:59:59 PM CT on each calendar day of the Entry Period. Eligible entries received on a particular Day will be carried forward into any subsequent daily drawing(s), as further detailed in Section 4 below. You are not a winner until Sponsor/Administrator verifies your applicable entry and you have fully complied with these Official Rules.
- 3. CT on December 14, 2018. COMPLETING THE ENTRY FORM CONSTITUTES YOUR AGREEMENT THAT YOU HAVE READ AND AGREE TO THESE OFFICIAL RULES AND THE SPORT CLIPS' PRIVACY POLICY, AND AGREE TO BE BOUND BY THEM. Completing the entry form also constitutes your willful agreement to opt-in to Sponsor's email marketing list. You may opt-out of Sponsor's email marketing list at any time, by sending an opt-out request by mail to Sport Clips, Inc., Attn: Privacy, 110 Briarwood Dr., Georgetown, TX 78628 or by using the "unsubscribe" link which will appear within any of Sponsor's email marketing messages. If you decide to opt-out, this will not affect your ability to enter the Promotion or your odds of winning a prize in the Promotion. See also Section 10 ("Privacy") below.

Sponsor's computer will be the official time clock for the Promotion.
